#### **How We Process Your Information**

We process the information collected for the following purposes:

- Marketing: We may send you promotional materials, offers and updates about our services

### **Data Security**

We take reasonable and responsible measures to protect your personal information from unauthorized access, disclosure, or alteration. However, please be aware that any method of transmission over the internet or electronic storage is not entirely secure.

#### **Data Retention**

We will retain your personal information for up to 10 years to provide our services, and as necessary to comply with our legal obligations, resolve disputes, and enforce our policies. We will then dispose your information by

- Deleting the data from our cloud-based system
- Ensuring backups are also cleared or securely overwritten

Under applicable regulations, we will keep records containing client personal data, account opening documents, communications, and anything else as required by applicable laws and regulations.

### How we store your personal information

Your information is securely stored using:

 Gas Engineer Software (https://gasengineersoftware.co.uk/), an online platform used to manage customer records, job details, appointments, quotes, and invoicing. This platform uses secure cloud-based servers to protect your data.

Access to customer data is restricted to authorised personnel only and is protected by login credentials and two-factor authentication where available.

### **Sharing Your Information**

We do not sell, trade, or rent your personal information to third parties. We may share your information with our trusted service providers who assist us in delivering our services, however they have an obligation to always maintain the confidentiality of your information.

We may share this information with:

- Subcontractors or engineers working on your job
- Software service providers like Gas Engineer Software (for quotes, invoices, and job management)
- Our accountant or bookkeeper (for invoicing and tax purposes)
- Call tracking platforms like Media Hawk or CTM

Legal or regulatory authorities if required by law

Why we may share this information:

- To fulfil our contractual obligations to you
- To comply with legal or regulatory obligations
- To manage our operations effectively
- To provide accurate, reliable service and support
